We were thrilled to succeed in hosting September WRSC and although over enthusiastic planning and expectation lead to discouragement, the experience itself and lessons learned more than compensated. Proceeds of \$195 from the conjunction function were paid to WRSC with check # 1171 to reimburse the regional activities committee. We organized and held a long awaited "service learning day workshop" on Oct 22nd and had the "celebration of recovery" clean time recognition function Nov 30th. The 7th annual "snow-bowl" function is scheduled for Feb 4th at Ojibwa lanes in Chippewa Falls.

CVA "public relations" chair attended the (NRAID) conference in June at UW Stout in Menomonie and set up an NA booth at the 4th annual western WI recovery advocates community awareness event in Sept at Phoenix Park in Eau Claire. The PR sub-committee has been developed from the ground up for 1 ½ years and efforts are attracting interest from professionals and other recovery organizations. Public Relations has been active in coordination with H&I to carry the NA message to the broader community.

H&I services have really taken off this past year. Panels and speakers are regularly brought into LE Phillips and Arbor Place treatment centers. We are involved in Interaction communication and literature donations
