RD Report

Dear Family,

This cycle has been very active. The June issue of NAWS News is out. The field testing phase of the Service System project is due to end this month. They are now considering what to put in the Conference Agenda Report. They said they would be putting in recommendations to approve and adopt the GSU/LSU portions. There will also be a transition plan in the CAT. NAWS is saying that the transition would be gradual, more of an evolution than a revolution. A lot of members do not like the term "unit". They are considering the terms "forum or conference".

On July 13, the Board hosted a webinar for all interested Delegates. After a 10 minute update and introduction, the floor was opened for questions. At one point, there were more than 80 participants, plus the BOD. NAWS still wants to eliminate Alternate delegates from the World Service Conference. When asked, the answer was that fewer people means better collaboration and better discussions. Their thinking for long term sustainability. They are also going to propose that NAWS stop funding delegates to the conference. Delegate funding may be available on an as needed basis. The Annual Report is also out now. It is 106 pages long, so I won't try to summarize it here. It is available for download on the NAWS website.

Chris, Harold and I have been discussing some proposals we would like to present at the WSC. We believe that a full and complete inventory should be conducted at NAWS. The last inventory was conducted in the mid 90's. This led to many changes, such as the standing committees being dissolved. Another was the creation of the Board itself. We wouldn't have enough time to discuss this and still get it into the CAR, but we would have enough time to have it ready for the Conference.

Another proposal would be to reduce the number of board members in proportion to a reduction of the size of the WSC. When a Board member completes 2 terms of service, they would simply not be replaced. The board maintains that the WSC is too U.S centric. Under the state, nation, province portion of the SSP, the number of US Regions could be greatly reduced. There are currently 18 WB members and 115 seated Regions. 9 of these Board members are from the U.S. The Board is full for the first time since its creation. In 2012 we elected 6 new Board members. The financial impact has been considerable. Details are on pages 57 through 69 of the Annual Report. As of the end of 2011, the total expenses were \$6,046,021. At the end of June 2012, the expenses rose to \$8,836,058. The World Convention cost over 2 million.

There are some interesting charts on pages 76 and 77. They detail the amount contributed by member groups. They detail the percentage of expenses covered by these contributions and the amount NAWS would need per meeting for Fellowship Services to be fully member supported.

The Iowa Region has contacted me about a multi-zonal service symposium. The proposal is an ambitious weekend from early Friday till Sunday noon. I am including the proposal, the tentative schedule, and a map with the minutes.

There is much more to discuss, and I'm sure you will have many questions. Thanks for letting me serve.

Greetings everyone,

At the May RSC, I was appointed to take some concerns to the June 16, 2013 WRSO BOD meeting. The following were in attendance at that meeting:

WRSO Treasurer/Office Manager

2 NA members (non-WRSO) were also in attendance.

It was established that there was quorum. Reports were read by BOD Officers.

There was discussion about current WRSO financial practices. It was determined that for transparency purposes, the treasurer will make adjustments to the way spreadsheets are formatted. This will make the treasurers' report more "user" friendly.

The WRSO Treasurer has, on occasion, issued personal checks to WSO to pay for literature/merchandise. In the future, all WRSO "payables" will be through the WRSO checking account. The treasurer will also look into how the WRSO can secure a business credit card. The personal check that was returned as NSF has been corrected. It seems the bank was at fault and paid the NSF fees. In regards to an "audit" of WRSO financial records, the treasurer stated "when I am in town, the doors are open". The WRSC should contact the WRSO treasurer to finalize the logistics.

The WRSO picnic is moving forward. For more information on this event, check out the flier on the table. There will be food, fun and fellowship.

There will be a new WRSO order form available very soon (hopefully this cycle). There will now be a "literature" order form, and a "merchandise" order form. The old literature form has 9 different quantity discounts on various items. We will be given the discounted price on 7 of these items from the first dollar spent; the remaining 2 items will remain quantity discounts. A separate form will be used to order merchandise. If available, please review these new order forms. There should be someone at this RSC who can answer any questions.

The WRSO will be adding 2 T-shirts to their inventory. They are: "*Eat Cheese, Drink Milk and read the Basic Text*" and "*Hug a Miracle – Hug Me*". The designs are in the final stages and will be available soon.

I gave the Office Manager a CD containing the WRSC Guidelines and a template for WRSO By-laws. The WRSO now has the means to reference the WRSC Guidelines when policy/procedure issues arise. Hopefully, the By-laws template may help the WRSO move forward in the revision of current By-laws.

Finally, I talked with the WRSO Secretary about concerns raised at the May RSC regarding this individual having relapsed. I asked the WRSO Secretary 2 questions.

1. What is your clean date? Without any hesitation, April 16, 2011.
2. Did you relapse? No, absolutely not.

I strongly suggest that in the future, any allegations made toward anyone not be from “word of mouth” or “second hand” information. If you believe someone is a “reliable” source, have them come before the WRSC and give us all the opportunity to hear what may have happened. “Hear-say” and “rumors” are 2 of the most destructive things a person can do to harm another person. This has no place in the WRSC and Narcotics Anonymous as a whole. If this happens in the future, the unsubstantiated statement(s) should immediately be dismissed without merit.

I believe that I have fulfilled the tasks assigned to me by the WRSC. We need to elect someone to continue being the important conduit of information between the WRSC & WRSO.
