Dear Family,

Many thanks to WSNAC for hosting this WRSC. This will be a joint report from both Delegates. At first, we both thought there was little to report beyond the CAR review, but alas, there is much to tell.

Right off the top, we are requesting funds. As authorized last cycle, we are asking for the funding to go to Kalamazoo for the CAR review hosted by the Midwest Zonal Forum. (MZF) We have been informed that the WB member who will be in attendance is Arne HG. It will be our pleasure to ask him any questions you wish to submit. Please do so in writing. So, here are the numbers.

We are requesting \$166.50 for the hotel, 880 miles @\$0.25 for transportation or \$222.00 and 3 days per diem for each of us @ \$30 per day. The total is \$568.50 to be split as follows; since Harold is driving, the transportation funding should go to him. I will pay for the hotel. Per Diem is to be split accordingly.

Therefore, we are requesting 2 checks. Harold should receive a check for \$312.00. I should receive a check for \$256 50.

While we are on the subject of funding, the WSC is coming very soon and funding needs to be secured. Airfare for the WSC is going to be about \$450.00 for the RDA. In order to secure seats on the available flights, we have to make arrangements now. We have to coordinate through NAWS to secure these flights. Therefore, we are also requesting an advance of \$450.00 for airfare to the WSC for the RDA. We will be asking for more in March. That will be for the hotel and per diem for the RDA to attend the WSC. We need the airfare now.

We hope you get a lot of information and insight from today's CAR Review. We will be getting more information next weekend in Kalamazoo. The WB will be work shopping the Conference Approval Track. (CAT) We will bring that information to you in March. Thank you for allowing us to serve.
