Good morning, family. The CAR is out and I am hoping that you all have received it and read it by now. There are only three motions in it but due to the new direction of the WSC the other information, such as the discussion questions, projected literature and other projects, requires your attention. I have already met with members of KMA, Big Rivers areas, along with Northern Lights yesterday morning. I have two more CAR reviews scheduled with the Inner City and NEW areas for February.

The MZF met last month and as you may have guessed our main discussion was the CAR. The other main topic was the Public Relations Handbook draft. How many of you have read this? How many of your areas are reviewing it? This has many of us concerned, as it will be replacing the H & I Handbook and the PI Handbook. According to popular opinion at the forum, the first four chapters were fairly well written

needing little change but . . . Chapters 5-9 and Chapters 10-13 are not good to say the least. The opinion among those of us at the MZF was that many will read the first four chapters, think the rest of the book is as good as that section and not even look at them. Only Chapters 1-9 in their finished form will be in the Conference Approved Track material, CAT, due out the end of this month. Since Chapters 10-13 did not come out for review and input till December 15th those chapters along with the addendums such as forms and such will not be available in their final draft until we see them at the World Conference. Now keep in mind that this is service-material and not recovery material and you do not vote on service material but I would like some input on this. The Conference Approved Track material will be available online at [www.na.org/conference/](http://www.na.org/conference/) by the first of February.

So here is what is happening in other regions. Areas in the Minnesota Region are currently doing inventories. The Service Office has gone to an all volunteer staff. They are currently financial stable and due to their extensive line of merchandise they have been able to drop the prices of literature lower than that of the WSO. Steven T., their RD stepped down just prior to the MZF and Tony M. the RDA has now replaced him.

The Michigan Region is currently holding H & I and PI workshops every regional weekend. The only problem they have with it is that only the choir shows up for it. They are trying to find a way to get other members from the fellowship to attend. Their convention was held with about 1000 in attendance. The Kalamazoo Area Convention will be holding their convention the same weekend as the MZF on the other side of Kalamazoo the first weekend of February.

The Indiana Region is currently working on a user manual for their areas to input information to the regional website. H & I and PI are both going strong but attendance at the RSC is lacking.

Metro-Detroit Region held their convention over Thanksgiving weekend with about 1100 addicts in attendance. All is going well and they have just moved their service office into a bigger facility.

Greater Illinois is currently debating costs of services. They have looked at shutting down their phoneline to cut costs. This brought about some serious discussion at the MZF over the concern for the addict in need.

They are looking at their other options first including distributing more Self-Support IPS to their members. Chicagoland has recently seen all 14 areas at their RSC for the first in a long time. They are working with a budget for the first time in two years and a treasurer. If any of you saw the CRC flyer it was a bit controversial, having the faces and names of the comedians and being general admission to the public.

As I previously reported here I will be in Kalamazoo the first weekend of February for the next MZF. This is our meeting with World Board members to discuss the CAR and CAT. I will be making a motion here today for \$100 to help pay travel costs for them to be there just as we do each time we meet in Kalamazoo.

Good Morning Family: WSNAC was successful meaning that 1) we pulled it off without a hitch even though the Board was the Committee; and 2) everyone had a great time. We had 409 registrations. The total registration revenue is \$12,262.50, Merchandise is \$8,339, Auction is \$1,480, the indigent/newcomer donations is \$468, and the guide shirts brought in \$240. Expenses weren't quite as easy to dissect. If I take the checkbooks beginning balance at \$15,072.22 and add in revenues of \$22,789.50, then subtract the expenditures \$28,086.86, I am left with 9,774.86. There are currently three unpaid checks and one reimbursement we are waiting on so if I include that number in the calculation the check book balance will be \$8,667, which is the number we gave you in open forum. However, this is not the whole story. I wanted to detail expenditures with committee responsibilities, and I worked till 2 in the morning trying to decipher the information. What I can tell you at this point is that I will continue to work with the treasurer until the two documents balance. Just so you know, this is the kind of puzzle I love to work on. Until then, I have the check book ledger, the quick report, and my worksheets that anyone is welcome to see. I plan on having this done in the next week or two so if you give me your email, I will be glad to send it to you ASAP. Otherwise, elections took place yesterday and we have new board members and positions. We have reduced our meetings from 5 to 6 to save money and we need to by a sturdy and safe enclosed trailer for the supplies.
