Good morning, family. Three weeks ago Patti and I participated in the World Service Conference in Woodland Hills, CA. I found it to be an extremely emotional and spiritual experience.

I got there on Friday; giving me a chance to see friends I had not seen in two years and to meet new ones. Saturday was Unity Day, sponsored by the West End Area, and I had the opportunity to attend several recovery workshops. On Saturday night after the speaker meeting, Marie, John and I sold Project Hope merchandise at the World Market.

Sunday morning started with the first scheduled recovery meeting at 7:00 AM. Saturday several of us held this even though it was not scheduled. At 9:00 we all gathered in the round tables for introductions and opening of the conference. There were delegate teams from 106 regions and 13 of the 15 WB members were present. Giovanna from Columbia and Michael C. from Spain were not in attendance due to illness. During this time we were also given cards to put on Giovanna's tree with suggestions on ideas we had for this topic and for the conference. We also had cards for questions to the WB and the HRP. When we gathered in the circle at the end of this session, the Serenity Prayer was said in over a dozen languages. The spirituality in that room was almost overwhelming.

After the opening session we went back to the round tables for the session on the theme of this year's conference, "It's All About Carrying the Message". This discussion brought a lot of great ideas concerning the areas in which we need to work. We also listed our own personal challenges and hopes for the week along with our A-HA moment, when the light came on for us personally. These were shared throughout the week and many of them will appear in upcoming NA Way magazines.

Our next session was the WSC Orientation. This session laid out the week's events and the WSC election and business procedures. At the end of this session we all boarded buses for the tour of the World Service Office and Mexican luncheon.

When we returned to the hotel we all moved to the risers side of the conference room for the session on NA Leadership ~ Now and in the Future. This was the first session of the week on Leadership Development. This included a PowerPoint presentation and discussion concerning the input received on the Leadership Issue Discussion Topic from this past cycle. This PowerPoint and all other PowerPoint and film media from the conference will be forthcoming to use in development projects.

On Monday morning, after the recovery meeting, we had a round table discussion on the Strategic Plan Overview. Communication was discussed and the consensus in the room was more regular communication between NAWS and the delegates was needed in the future. Since the WSO is short of writers at this time, email and bulletins concerning ongoing business will be utilized. A discussion ensued concerning giving the WB the ability to create service IPS and other booklets between cycles. A motion was in New Business later in the week on this which passed. If you open the First Draft Record of WSC 2006 Decisions to page 8 you will see the order of importance that the conference participants classified each of the Project Plans as they were straw polled later in the week.

The next session held that day was the NA World Services Report. After introducing the staff members of the WSO, a report was given by Anthony on the work in Fellowship Development, translations, literature production, and fellowship support for this past cycle. It was during this report that Anthony was able to present Sohshi, the delegate from Japan with the first printed copy of the Japanese Basic Text.

There are three new formats for pieces of literature already written: The White Book and Behind the Walls are now available unstapled for use in H & I efforts. These can be sent into correctional facilities. The pocket-sized readings set is now in a little larger print and a four-fold instead of three for those of us with bad eyes.

A memorable part of this report concerned the work that has been done in the fellowship in Iran. At the present time in Iran there are about 4200 meetings and between 50,000 to 75,000 recovering addicts. A service office had to be established there to handle literature development and distribution. Between July 2005 and March 2006 51,573 BTs, 27,272 IWHWs, 26,249 Intro Guides, 59,720 White Books, 17,704 Step Working Guides, and 1.1 million were sold in Iran. Anthony and Becky went into Iran to assist them in their efforts. While they were there they attended the Iranian NA convention with about 17,000 addicts and about 2500 of them were women. So to those who have asked about women in Iran being allowed to recover, I can say Yes. The WSO has learned some things from the way our members in Iran are handling literature distribution. They have been packaging all of the separate IPS together and all of the books together in bundles for sale to their members. This is something that the WSO had never considered prior to their visit. If you look to your Regional Donations you will see that the region of Iran has over the past two years donated over \$14,000 to NA World Services. This is over \$11,000 than the Wisconsin Region during that same time period and Iran wasn't even a seated region during that time period. Sadly the delegate from Iran was not able to gain entry into the U.S. for the WSC.

I have with me copies of the Basic Text, It Works How & Why and Intro Guide in Iranian. I have donated

the Step Working Guide to Project Hope for their auction. It took 3 months travel by boat for these to reach the WSO and they showed up during the conference. Thanks to Patti for her quick thinking in learning of these and we were the first to purchase them before they disappeared.

At 12:30 we broke for lunch and the women were able to attend the women's luncheon. I can't report on this as I was not there.

After lunch the NAWS report continued with the discussion focusing on the workgroup's progress on such things as the Basic Text Project, PR Handbook, PR Strategy, and WSC Seating. The Basic Text project is now past the input segment and the workgroup is currently reviewing the over 700 stories and are attempting to fill in gaps where they feel certain issues are missing. The PR Handbook was discussed and as I did when we discussed this at the Multi-Regional assembly in January, I made a suggestion that this be considered a work in progress and be released in a 3-ring binder with chapter divisions for the convenience of updating specific sections individually. Later on Monday I wrote a motion for New Business pertaining to this. The NAWS website will be completely overhauled so watch for the new and improved na.org over the next couple of years. One major improvement on it is the development of the database interchange system. Regions like Wisconsin with databases for their meetings will be able to easily link to NAWS and updates will become much simpler. Upon the completion of this part someone will be able to print off regional and area meeting lists directly from na.org. I am the contact person for Wisconsin to NAWS at this time. It will be pertinent that your areas properly monitor the regional site to be kept current with your meetings, as this is what will be uploaded to NAWS database.

One topic that came up and was debated heavily on Sunday, Monday, Tuesday, Wednesday, Thursday, and Friday was the report in the CAR concerning the possibility of common needs or special interest workshops or meetings at next year's World Convention. All together over the week I am certain this and all its tangents were debated for about 5 hours. During one of these discussions I looked at the fact that the Wisconsin Region has over a dozen common needs meetings and most of our conventions hold these workshops and I put forward a motion to hold common needs workshops countering a motion disallowing them at this or any World Convention. Since our primary purpose is carrying the message to the still suffering addict and common needs meetings and workshops are helping do this it should not have been as big a concern as it turned into in the debates, in my opinion.

We also discussed the Criteria of Recognition of New WSC Participants since the WB added the regions of Western Russia, South Africa, and Iran to the list of candidates after the workgroup disqualified the process was discussed.

After the NAWS Report was completed, we turned our attention to the HRP Report. There were many questions pertaining to their selection process. With 10 open positions for the WB they only offered us 17 possible candidates. Guidelines allow up to three candidates for each position. There were several who had been nominated by their region, or Zonal Forum who did not make the final cut including two from Wisconsin. In the end we got very little in quality answers from the HRP though they did a great job of dancing around the questions.

One big question that was asked was how the scoring process worked for candidates to get through the process. Questions were asked concerning the difficulty of the World Pool Information Form. There were requests to simply this form down to one page, if only for workgroup participation. Since one-page would be insufficient a motion to create a 2-page information form for workgroup members passed later in the week. If someone wishes to be considered for WB or HRP membership or WSC co-facilitator they would still use the larger form that you have been given.

After dinner Infrastructure was discussed. A report was given on the feedback that was received on this issue discussion topic over the past cycle.

Tuesday morning I attended the 7:00 recovery meeting. Our first order of business was the HRP Open Forum. I have already reported on the discussion from this session. Very few delegates walked away this discussion satisfied with what they heard. At least year's conference the HRP had held a workgroup to show delegates how the candidate process worked and it has been suggested that they look at doing this again since there were so many unanswered questions this cycle. I know that I attended that workgroup and it answered some of the pertinent questions being asked.

We next moved into the WB open forum. This started with WB recommendations to Old Business motions.

If you look at your First Draft Record of WSC 2006 Decisions on pages 3-5 you will see these motions including the amendment to motion 3 that changed it to “To change the time frame for approval form recovery literature from the current minimum of 150 days to a minimum of one year...for book length pieces; the World Board may exercise its discretion to set a shorter period for shorter pieces of literature but that period will not be less than 150 days.” The WB answered the questions that had been submitted on Sunday and then opened the floor to other questions. As I stated earlier, common needs meetings became a debate for a large portion of this session.

After lunch on Tuesday we discussed the Old Business motions. As you can see in the First Draft Record of WSC 2006 Decisions, Motions 1 & 2 failed and motion 3 passed. After this session we went into discussion on the Issue Discussion topic of Our Public Image and what can be done to improve it. One of the most important things we can do is be more visible at events that can build on Our Public Image. We can also watch our behavior at our meetings and functions. Another concern that was brought up was predators at our meetings and how we can protect our members. Our Public Image ties directly to the topics of Public Relations, Who’s Missing from Our Meetings, and Leadership Development.

Tuesday we finished up with the topic Who’s Missing from Our Meetings addressing common needs. This brought out discussion about youth, old-timers, and others who may be afraid or feeling left out. As you may guess this brought up more debates on common needs meetings. Interestingly enough there were a large number of youth sitting in the gallery that evening. We got input from some of them, one who stated very clearly that there are issues that our young people are dealing with such as parents, difficulty in school, and peer pressure that they do not feel comfortable talking to older members.

On Wednesday morning, after the recovery meeting, we got into the discussion of the budget and project plans. This included more discussion on targeted literature and basic service tools.

At the end of the session on Wednesday all conference participants boarded buses for the Cal Amigos Ranch for the luncheon. Damn but that was a great meal! After the lunch others who were attending the conference came out to join us. Since the weather report predicted rain for the afternoon, NAWWS had found this great comedian and musician to entertain us after we ate. Mother Nature proved the weatherman wrong and we were able to spend about an hour and a half outside at the ranch with some members playing softball, soccer, football, volleyball, ping pong, and horseshoes. Everyone else just relaxed and had a great time. This was a necessary and well timed break.

Upon return to the hotel Zonal Forums met. We discussed the election process explaining it to those who had not been to the conference before. I also brought up the topic of Project Hope to the other members to try to get their assistance. Since the MZF will be held in KMA in July we have requested that Andrea give a presentation on Project Hope.

Thursday morning I attended the poolside recovery meeting again. By the way, the weather in Woodland Hills during the week we were there was actually colder than it was here so these meetings were great for waking up. Good recovery and 45 degrees wakes you up real well.

Our first session of the day was the WB meeting and forum. We discussed the New Business motions. The WB answered questions submitted and we discussed the service material approval process. The consensus of the body was to allow the WB create and approve smaller pieces during the conference cycle. To see the results from the straw polls taken on New Business motions please refer to page 11 of the First Draft Record of WSC 2006 Decisions.

After lunch we approved budget and project plans and held elections. If you look at page 9 and 10 you will see the results of the elections. This process did not run smoothly since there were two challenges on members up for election to the WB. On page 9 it explains how these are handled prior to it coming to the floor of the conference. The process of resolving nomination challenges was not a comfortable one for anyone there since member’s integrity, honesty, and levels of recovery and service are questioned. On page 10 you will see the results of the election. Five of the newly elected WB members are from the U.S., one is from Canada and the last is from Greece. The straw poll to prioritize the project plan was also held.

We then moved into the discussion on Fellowship Development. The WB reported on their travel activities during the past two years. Film and PowerPoint presentations were used to emphasize the work that was accomplished. At the present time a fourteen year-old member from Soweto, South Africa and his mother are in the process of translating our literature into Swahili. Work is being done in several countries all over

the globe including China and South Korea. By July we should have copies of all of this media for you including a digital report from the delegate of Iran. During this session the WB reported on plans for this coming cycle.

After dinner, Zonal Forums who met could give reports. John H. and Brian H. from Michigan gave ours. Friday the opening session was a discussion on Leadership Development was facilitated by Jim DeLizia, a professional instructor on this topic. It was a very dynamic interactive session. I would like to see us use the tools from this session as a topic for workshops here at the regional level.

How to Be An Effective RD was the next round table session. This session allowed members to hear the experience of RDs past and present. We then discussed in small groups how to best serve the fellowship. After lunch we got into discussion on the New Business motions. You will find the results of those on pages 6 and 7 of the First Draft Record of WSC 2006 Decisions. The motion I had made concerning the PR handbook in binder form was referred to the WSO as input instead of to the conference floor. This will allow them flexibility in its creation since 3-ring binders are only used here in the U.S. Other countries utilize other binder formats. The PR Handbook will be revisable as needed.

As you can see by the results of the voting the topic of common needs was not as split as it would have seemed. Over 2/3 of the conference voted pro to this topic.

The regions of Western Russia, South Africa, and Iran were voted in as newly seated regions. North Carolina and the Bluegrass Appalachian regions were not due to the reasons given by them for consideration. Arguments against these seatings mainly dealt with the distance and levels of poverty but also because the body recognized the need to slow the rate of U.S. regions being seated.

We finished the day on the discussion of the Area Planning Tool. After discussion this tool will be flexible and will be revisable as necessary. Please take this tool and use it in your areas. If you see changes you would like to have made to it, send this input to the WSO. We finished up business on Friday night at 11:30. Saturday morning we met for our last session Moving Forward with a Common Vision. Several ideas were brought up to make the conference and communication better including video-conferencing for delegates who cannot attend due to government issues and the possibility of a webcast of the WSC for members of the fellowship to watch the conference over the Internet. We then had the closing lunch with several delegates saying goodbye. Saturday evening's speaker meeting had delegates from several different countries.

At the World Market that night Marie and I again sold Project Hope merchandise. I am happy to report that when I got home I was able to send Andrea just over \$1000 from our sales.

Throughout the week I had several discussions concerning Project Hope and gave out as much information as I could. At this time delegates from Japan, Spain, Germany, the UK, Ireland, India, along with some of the Latin American regional delegates are taking this information back to their regions to try to start their own Project Hopes. In our discussions it was great to see the excitement building as they saw what they may be able to do. The Japanese delegate, his translator and I spoke of the topic for almost an hour since they just last November started bringing NA into correctional facilities.

The last thing I need to report on is the Regional Donations Report. If you page through this you will see that we are not doing so well on our donations to help support our World Services. Our donations to NA World Services over the past conference cycle added up to \$2894.84. Total donations to NA World Services was \$1,449,762.07. This means we donated about 2/10 of a percent of total donations. Please take this back to your areas. The Wisconsin Region and its areas hold 6 conventions per year but we are not doing our part to support our services.

Last but not least, I cannot thank this region enough for the last four years of my recovery. I truly have had the experience of a lifetime. Twelve years ago when I was sitting in a jail cell trying to stay clean I never imagined my recovery would have come this far and I would have been given this opportunity. These past four years have shown me so much. I regret to have to end my work as your regional delegate but I need to say that everyone needs to experience what I have. You and your recovery will be rewarded by it. Thank you for allowing me to serve.

Hi to my NA family in the WI Region, thanks you so much for electing me as your RDA and allowing me to be of service to you and this fellowship in this capacity. The experience of being able to interact with addicts

from around the world and hear their stories about their regions was incredible. I attended the world services conference for 2006 and it started on Sunday April 23, opening at 9:00 am. I am going to try and give you all an up front and personal experience of what went on at the conference. In the opening there were introductions of all the conference participants and it was the first official roll call. The conference rooms were divided into two sides on one side there are tables for small group discussions and on the other side there are risers with tables and chairs for the RD's and RDA's on three sides with a long table and podium at the front. The conference was asked if South Africa and Western Russia could sit in the conference as non voting participants and the conference passed that they could. They were over joyed and received a standing ovation from the conference. This portion of the conference closed at 10:30 am with the Serenity Prayer being said in all languages present. This was really something to hear.

The next session was to reflect on the theme of the conference, "Its All About Carrying the Message". We were divided up into small groups to get to know each other and discuss what our greatest challenges and highest hopes were for this conference week.

The conference participants were provided with more then one way to communicate our thoughts and ideas. One of the world board members who is very ill and could not attend the conference from Columbia created an idea tree which was put on the wall in the conference room for the entire conference. We were given cards and asked for our input, questions, solutions and then they were taped to the tree and collected by the board to be used as input to the forum discussions during the week. There were also question boxes for the world give input to the CAR discussions or anything else we wanted to ask or say also.

The idea of having all these different avenues for input was for the comfort of the participants. Knowing that not everyone wants to speak at the microphone or is as forthcoming discussing topics and asking questions in front of a large group of people especially if it is your first time at the conference. So all these avenues for communication were used throughout the week and the input was incorporated into our discussions sessions. Another tool that was provided to us and shared throughout the week of the conference was what was called "You're a-Ha Moment". To remember our primary purpose of carrying the message of recovery we each wrote down when we really got the message. Throughout the week of the conference at different times addicts were called upon to read and share their a-Ha moments with all of us. To hear addicts from different countries and languages share how they got the message of recovery, in their countries, in their regions, at all the different levels that NA exists and is or isn't developed and to hear the same message of recovery, well to say at the very least it was heartfelt and emotional.

There was an orientation for the conference and the election procedures. We also went to an open house reception at the world service office. We were taken in small groups throughout the entire structure including the warehouse where all our literature comes from, the world board conference room and all the offices were the paid staff & "Special Workers" do their jobs and help provide the fellowship with all that we need, for all that we do, and provide in services to a World Wide Fellowship.

I was in the elevator with an addict from South America and the co-facilitator who could translate for him. It was the first time this addict in his 25 years of service had been to the office and he cried out of gratitude for all the help they had received from the office and the people that work there. He said for all these years he had no visual picture of the office or most of the people there, just a voice at the end of a phone or on occasion a world board member sent to their region to give them support. He was so grateful to see this place and to be standing in the building where they get their translated literature form.

I also had the privilege of meeting a man named Bob who is the oldest working member of the office and has been there since it started and watched NA grow and go from Jimmy K's trunk of his car to what the office is now.

The last session of the day started at 7:00 pm and we had discussion on leadership in Narcotics Anonymous now and in the future. The world board and the human resource panel presented the first of two discussion for this week about leadership development and how it impacts NA World Services. The discussion was about how does an addict who comes into an NA meeting to get clean, how do we encourage, and help each other to develop and grow in leadership skills, so we have world board members to take on the tasks that we as a fellowship direct them to do say 10 years from now or 20 years from now. What can we create to improve the ability of our members to take on these roles? How can we use the word leadership in our fellowship in the correct terms of a trusted servant? This session ended at about 8:30 pm. In the NAWS

reports and at the NAWS site there is a lot of information that can be used for on going discussions in our region and our area. All of the tools for discussions on this topic or any other topic are within this report and can be implemented in your areas to stimulate fellowship discussion on the very topics we make decisions on as a fellowship every two years at the conference. If we don't discuss it, we can't get any kind of consensus.

We had two sessions with Jim Delizia on leadership and he is a consultant we have used in our fellowship many times to teach us techniques on an assortment of topics. This is some of the information he gave us in an interactive session: **1-**Leadership development has to a system, a process that is applicable to the addict. **2-**An addict comes to a meeting for the first time and needs to be orientated. He encounters a strong atmosphere of recovery; he encounters a well-organized group. **3-** We want to addict to have a positive experience from the start. **4-** Training, coaching and encouragement. **5-** Verbalize in round table discussions on leadership. **6-** Teach the traditions and set up a system with leaders. **7-** Use mentoring to the new leaders for smooth transitions from leader to leader to help change the culture at a meeting or in service at any level. Stop stating what is wrong and have a dialogue that encourages the changes, problems and let them arise naturally. **8-** "Be the Change" **9-** Cultivate the newcomer. **10-** Loose the negativity. **11-** Work Hard **12-** Have humility **13-** Learn our limitations **14-** Identify our strengths **15-** Identify our strengths and weaknesses **16-** Develop the knowledge of who and why we are serving **17-** Have a change in attitude from the old to the new ways of thinking **18-** Talk about leadership, so addicts hear that. **19-** Have consistency **20-** Stop resisting change and listen and encourage new ideas. **21-**Give our leaders coming up a time to practice.

The path to change is: attitude, belief, language, verbalizing & behavior. Have everyone share with each other in a workshop setting or round table discussion "what the worst and best service experience that each has had". Think about and discuss these above ideas in your areas. Do not be in competition with each other, be of service to everyone. "A candle loses nothing by lighting another candle" Erin Majors strategic plan overview.

For this discussion we were in small groups and did round table brainstorming. The majority of the discussion was to talk about what we think is most important to accomplish in each of the key result areas of our plan, that are: **1-** Communications **2-** Fellowship support **3-** Resources **4-** Leadership and management, for the next cycle into 2008. Any ideas or input anyone has can be forwarded to World Services. Areas can have these discussions and provide input. The idea of talking, talking, talking and discussing a lot more in this fellowship is so the fellowship is involved. Addicts that participate in something that they are a part of, when it means something to them, that they are personally invested in, will not only help to have trusted servants in the service structure but will continue to help our fellowship carry the message world wide.

NA World Services Report

The NAWS report is available for everyone to read at the NAWS site. There was a lot to cover in a short period of time and these were the highlights. The staff was introduced that works for us at the office and an overview of the functions of the office were described. There was discussion about literature production, fellowship support to provide the services we want done, the website, our branch offices and publications.

The biggest discussion about literature distribution about literature distribution was in Iran. There is a branch office went there. The purpose was to help setup and to make sure that this office was running like all the other NA offices in the world.

The distribution of literature in Iran in the last 8 months, as of July 2005 to Feb 2006 area as follows: **1-** White Books-59,720 **2-**Introductory Guide-26,249 **3-** Basic Text-51,573 **4-** Step Working Guide-17,704 **5-** 1.1 Million IP's sold in the last 8 months. In Iran they sell IP's in bundles and call them service packs in lots of 100. **6-** I believe it was stated that 309,346 key tags were purchased by Iran in the last 8 months.

In Iran they had a convention and there were 17,000 addicts in the room and 90% were from that

one city. 2500 of those addicts were woman and in the picture they were sitting in the balcony behind a black mesh screen. Women can only be in a room with a male if they are married to them or related to them. Iran is growing so fast that by the time of the conference they said there is probably 50,000 addicts in recovery now. Because they do not have a lot of sponsors, one sponsor will sponsor 125 addicts and they go thru the steps like a class completing all 12 steps in two years. How Iran got started with recovery was a religious leader read over our NA literature and seen that it was not in conflict with the state sponsored religion so it was allowed. The question was asked if NA is violating any laws, because of sanctions or the terrorism in Iran? The answer given was no. We are not a political organization. I also was one of the lucky ones that found out that Iran had translated two books into the Farsee language and shipped them to the conference. It took 3 months for them to get there by ship and because they were damaged Anthony wasn't going to sell them. But I begged him to sell them and he agreed. There was only six of the Introductory Guide to Narcotics Anonymous and only a few boxes of the It Works How and Why.

The website is to be redone with a facelift. The number one way to order literature to date is online. Another new added upgrade to the website was that the webmaster can contact Lori to get the correct text file information that she uses to put in area and regional meeting lists which will be in the database and can be changed or updated at anytime. Only the RD and the webmaster will be able to get the access code and they will need to fill out a confidentiality form and be given a password code. The FTP site at NAWS is going to allow us to access information and download it for use in areas and regions. If anyone has any ideas for the restructuring of the website please send it in to NAWS. There also was a request for regions to send all their guidelines, convention, regional, areas so when others call the office they can use them to develop their own.

Literature updates are: The Little Basic Text will be coming out in paperback slightly larger then the hardcover. Also Just For Today and It Works How and Why will be coming out in half pint size sometime when we get closer to the San Antonio World Convention. We can now also purchase the Little White Book and Behind The Walls without staples in them so they can be taken into correctional institutions. The old style medallions will be sold as a key ring until they are gone.

The Japanese Basic Text has been translated after many years of struggling and they area extremely excited about the book. The Basic Text project personal stories will be out for review and input by Sept 2006 to March 2007. By Sept 2007 the piece will be ready for action to be taken on it at the 2008 conference. This is the break down of the stories that were received and the years clean sent in. 30 years-6, 20 years-79, 10-20 years-204, 5-10 years-137, 1-5 years-185, less than one year-39, unknown clean time-41, 160 plus were from outside of the US. They were really happy with the participation and feel it is a good mix of experiences. There are three active lawsuits going on with MA at this time. There was not any disclosure about these lawsuits because they are active and currently going on. There was discussion about insurance. It was stated that every region should have liability insurance for events and fundraisers, it is absolutely necessary. All regions need to check their policies to make sure that if we are named as a defendant in a lawsuit we will be covered by our insurance. Paying for a defense team is very costly and the bottom line is no one should use the legal system to deal with a problem with anything in NA but it does happen and we need to protect ourselves. The office is going to be writing a new intellectual property statement saying NA has no control, so we are not liable.

At this conference even though we didn't call it consensus-based decision making we did do it a lot and are getting closer to the actual concept.

I attended the women's luncheon and a women named Sally was there who was around at the beginning of the start of NA and the writings of the Basic Text. She shared all about Jimmy K and how the addicts around at that time always thought he would write the book. She shared all about

the Basic Text and her experience as she remembered it and it was awesome to hear.

There are copies of the new and old business motions for all the RCM's and I have made copies of my report and the daily agenda's that we followed for each day of business conducted with a cover statement called the World Service Conference. All the rest of the reports the RD has made copies of. Again I want to thank you all for allowing me the privilege to be of service in this capacity. It's been an honor to participate as the RDA for the WI Region.

Dear Family, the Public information Subcommittee met yesterday. Eight Areas were represented, and 15 members were present. The new Helpline numbers have been issued, and many Area's are already up and running. There were many questions and much discussion about the new Helpline. The Region will continue to use the old original number, 800-240-0276. That number will be transferred to the new service within 4 to 6 weeks. Until then, the Region will use a temporary number, 1-866-276-2416. Watch the web site for further updates. Questions about the set-up and operation of the new Helpline can be brought to Larry D. There are still Areas that have not yet set up their Helpline or recorded their meeting lists. This is a Region wide effort that needs the cooperation of all the Areas to become a fully functional interconnected network of Area Helplines. The Region will be terminating the current answering service, and with it, central access to the Regional meeting list. It is the responsibility of your Areas to put your meeting list on your Helpline and keep it current. The central Regional number will serve as a hub connecting all the Areas.

This one is embarrassing. It has come to our attention that the Helpline number that has been published for RRAGS in the Regional directory for many years is inaccurate. The number that is published is, in reality, a sex line. Please cross it out on any and all Regional directories you see. This will, of course, be corrected in future meeting lists. The new Regional number for RRAGS is connected to the REAL RRAGS Helpline. Meeting list updates are coming in steadily, and are being handled efficiently. The new directory is due at the July RSC. The deadline for updates for the July Directory is June 24. Please send all updates to the web coordinators through the web site. All of the new Helpline numbers will be published in the new directory. The meeting list will also be in need of restructuring. It has reached its practical limit, and new ideas for the future of the meeting list are needed. Please bring your ideas and proposals to the July conference. The web site is up to date and running smoothly. For professional and personal reasons, Nick B. will be resigning as one of our web coordinators. He will continue to serve temporarily, but we need a new web coordinator very soon. We wish to thank Nick for his service, and wish him well in all his future endeavors. Please announce this to your Areas. Anyone interested in this position should contact us through the Web Coordinator link on the web site.

Due to a complete lack of human resources and a shortage of financial resources, we were unable to attend the WAAODA Conference earlier this month. Local Areas failed to provide human support. Promised financial support failed to arrive. We were noticeable at this conference by our absence. This conference provides access to the largest number of treatment professionals in the state. Part of our P.I. Subcommittee's stated purpose is to inform "...those who are interested in helping the addict who still suffers in our Region." In this, we failed.

This is not the first time that a shortage of human and financial resources has led to such failure or near failure. WAAODA had to be rescued financially last year. Two years ago we had to import human resources to support the Women & Poverty Conference. This was done on short notice and at considerable additional expense to the Region. It has become common practice to have to scramble at the last minute just to find a few people willing to step up and carry our message to the professional community. Our poor performance has caused serious damage to our public image. It's time that we, as Trusted Servants, take responsibility for our failures and poor performance and begin the process of rebuilding the human and financial resource network needed to carry our message. Our subcommittees need willing, trained people. That begins right here and right now, with us. It was noted that this Region is home to six conventions, each with committees spending thousands of dollars to celebrate our recovery, while our subcommittees struggle to carry the message the message to the still suffering addict. Let's put our house in order.

Public Information in Big Rivers Area attended a "Meth Conference". They distributed information packets and learned much from those attending. They are also sending information packets to treatment facilities and are engaged in a bus sign campaign.

The election for P.I. Chair is next cycle. I have served as Chair since September 2003. That's nearly 3 full terms. After much discussion and soul searching, I have decided that I will not accept a nomination for another term as P.I. Chair. I believe that term limits exist for a reason, and the reasons are valid. It's time for a fresh perspective, new ideas, and new direction. This comes with new leadership. To this end, the P.I. Subcommittee voted unanimously to nominate Larry K. to serve as the next P.I. Chair. His experience and leadership will bring a renewed vitality to the P.I. Subcommittee. I will continue to be active in P.I., and I will continue to serve the Fellowship in whatever manner the Region deems appropriate. It has been an honor and a privilege to serve. I thank all of you for your support, your guidance, your patience, and most of all, for the opportunity to serve.
