Dear Family,

First, thanks to North Central Area for hosting this RSC. The RD Team attended the CAR / CAT workshop in Kalamazoo, MI on January 24-26. A WB member was present and conducted the review. The CAT review was on Friday evening, with a PowerPoint presentation. We will present that to you today. There are several items in the CAT that depend on the passage of motions 2 through 6. The project plan for future development and funding for the SSP depends on motions 4-6. There is a large section devoted to amending and revising the Guide to World Service. Some of the proposed changes depend on motions 2 and 3.

Not surprisingly, many of the same questions that came up here in January were also asked there. Again, also not surprisingly, the WB member did not give many direct answers, deflecting to "a larger conversation at a later time." The budget is difficult to read and understand if you are not an accountant. We can discuss specifics on the floor.

I presented CAR / CAT workshops in both Green Bay and at Project Hope in Sheboygan. Workshops were also presented in SEFA and in Milwaukee by their respective RCM's. We have asked you to get your Area tallies to either myself or Harold ASAP. We will be leaving for California on April 25. We hope you have some for us today as well as general and specific direction for the WSC.

We will try to text, email or phone updates from the conference, time permitting. It will be a very busy week. There will be many discussions throughout the week concerning many of the topics in both the CAR and the CAT. The Conference Report with the complete agenda for the week is not yet available. It is due this month as well as the complete Conference Record from 2012. As always, we will take copious notes and provide a full report at the WRSC in May.

It was mentioned that Badgerland and Rock River's RCM's gave a CAR review in their Area's also.

REGIONAL DELEGATE ALTERNATE: Present, read the following report on the floor. The WSC is only about a month and a half away. I am anticipating a focused and possibly intense conference. This is why the RD team has done their best to keep the WRSC participants informed as to the goings on with NAWS and the worldwide fellowship. The WSC participant discussion boards have quieted down over the past month or so. The boards are being used more so to get head counts for dinner for those who are arriving early and also having a recovery meeting at the host hotel prior to the start of the conference.

On February 8, 2014 I facilitated a CAR review for North Central and Woods & Waters areas at a combined function. The review was attended by about 20 members. We watched the PowerPoint Presentations created by NAWS. Questions were raised about the new IP#29. The review participants seemed secure in their knowledge of Motion #2, (Alternate attendance at the WSC) and Motion #3 (Delegate funding to the conference). However, Motions #4-6 met with some lively discussion. I came away from the presentation with the impression from the participants that these motions were being force fed to us and that there are still many questions that need answering. Overall, there was good participant discussion during the review. I am asking for the WRSC to reimburse for round trip mileage for the presentation. I am submitting the proper paperwork to the Treasurer for reimbursement.

It is also time to ask the WRSC for the remainder of funds allotted for me to attend the WSC and a small reimbursement for the purchase of the airfare (I received \$450 for the ticket; the actual cost was \$534). I believe the following figures for the remainder of funds for attendance at the WSC, and reimbursement are accurate; they are as follows:

B There is a typo in the draft that NAWS would like to fix. The text mistakenly refers to In Time of Illness not In Times of Illness. (CAR – Page 48, first paragraph after the bullet points)

3 In the CAT under 'Issue: Clear, Consistent Understanding of NA' in 'Approaches' One of the ideas is item 1 – Create a new PR pamphlet (similar to Information about NA) for professionals regarding medicalization of addiction treatment and the NA Third Tradition. (CAT – Page 10)

4 Traditions Book Project (TBP) – This is the next phase of TBP (*if approved at WSC*):

This project is a “Bridging the Gap” type of program in which clients of a treatment center in Minocqua would be offered the opportunity to receive the name and phone number of a current member of NA who resides in the area of Wisconsin where they came from and would be returning to after leaving the treatment center. The idea is that developing a telephone relationship with a stable member of NA from their home area would go far to help the newcomer find their way to an NA meeting when they get home from their stay in the treatment center. Part of the help I was asked to give was to reach out to all the other areas in the Wisconsin region and begin developing a contact list of willing NA members who would accept the contact form a newcomer/client in Minocqua. Last week I sent emails out to all the areas I found on Wisconsinna.org to have an email contact listed therein. I received a few responses already from trusted servants who are going to bring this to their ASC’s. I am also asking all RCM/RCMA’s to bring this concept back to their areas for consideration and action. The “action” would be creating a phone list that would be forwarded to Carl A from Woods & Waters. People on this phone list should be willing and able to receive phone calls from newcomer/clients from this treatment center in Minocqua.

We realize there may be a lot of discussion on the details of such a project and its adherence to our traditions. These conversations are important and should be held here, at local area conferences and among NA members at-large. Questions regarding this project that we cannot answer here and now will be forwarded to Carl A. for his Area's consideration.

If there are any people here today who would be willing to add their names to this growing phone list I will be passing around a sheet of paper. I will also be attaching a copy of the phone list blank and the actual document used by the newcomer/client to request a name/phone number of an NA member to this report when I send it to Nancy.

There was a request to change the order of the day to be able to deal with the WRSO Pool elections. No one blocked this request.

Jerry S. read his service resume.
