I don't know if anyone has noticed, but our bank fee from M&I is \$45 per month. I looked to see if we could get a –0– fee account, and we can. The problem is the \$45 that M&I takes out of each month is not for services it is for having two signers on each check. Two signers are for the safety of this Region's funds. I would like to propose though, that we try switching the type of account to only one signature on a check. We can still have multiple people as signers; just two don't have to endorse each check written. This does take away, the second set of eyes as money leaves, but I think we could set up an alternative, such as the checks being initials under the comments or something. We would be saving \$540 per year. I also can add a copy of the bank statement to each report I submit, that way everyone can see that what is on the report matches the bank. There is no cost to try, the checks are fine to use with one or two signatures. The account will stay the same so we won't need new checks. It is an internal code change the bank will do.

RD TEAM GAVE A JOINT REPORT

Dear Family, First, we'd like to thank Scenic Bluffs Area for hosting the RSC this cycle. This will be a team report as we have been working together and separate reports would be redundant.

We were directed to research the IP "For the Parents and Guardians of Young People in NA." We've done the research, and here are the results. The original review and input draft of "For the Parents and Guardians of Young People in NA" became available to the Fellowship in April 2007. The draft went through the review and input process until a final draft was published in the CAR 2008, addendum E. The explanations and motion for approval of both the Youth IP and the For Parents IP are located in the CAR 2008, pp. 31-32, motions 7 and 8. To the best of our knowledge, no challenges to the content on the basis of Tradition violations were presented throughout the review process. The motion to approve was passed by a voice vote on the floor of the WSC.

It was M/C World Board, Motion #8:

To approve the draft of For the Parents or Guardians of Young People in NA contained in Addendum E as IP#27.

Intent: To have an informational pamphlet that helps explain Narcotics Anonymous to the parents and guardians of young recovering addicts.

Action: Motion carried by voice vote.

The results were published on page 7 of the WSC 2008 Summary of Decisions.

The following is an excerpt from the Public Relations Handbook, Chapter 6, p. 55. Please note the references to Nar-Anon and Families Anonymous. These also passed without challenge.

**Cooperating with parents and guardians:**

Working with youthful offenders may include interacting with parents or guardians. Members, in the spirit of cooperation, can inform parents and guardians about resources for family members of addicts. Nar-Anon is one of those resources, but there are also information lines, community services, and Families Anonymous, to name only a few. Cooperating with parents and guardians does not include delivering messages or gifts to incarcerated minors. The facility and area guidelines can outline the appropriate level of cooperation with parents and guardians

All of the above information has been confirmed as accurate and correct by a BoD member. We also contacted Fellowship Services at NAWS. Steve R. Fellowship Services Team Leader responded:

*Hi Chris – It was good to talk with you today. Attached are the portions of the 2008 CAR that discuss the IP. I hope that is helpful. And again, editions of NAWS News from the 06-08 conference*

Regarding forwarding a regional motion, the excerpt below from page 14 of *A Guide to World Services* offers direct information, but to help provide a comprehensive perspective, I have gathered a few excerpts:

*From the Introduction: Regional motion deadline: Motions must be received by 1 August and be in CAR-ready form by 28 August 2009. We encourage all delegates to begin a dialogue with the WB ahead of this deadline. We will attempt to help you find ways to get your issue discussed by conference participants.*

*From page 11: Delegates should not delay submitting their ideas until the deadline for the Conference Agenda Report. Using a regional motion to forward an idea is not the most effective way to have an idea discussed and will likely postpone full consideration of their ideas as projects for at least two years. The conference has repeatedly voted to not have production issues related to literature, key tags, and medallions decided through the CAR. These types of issues should be sent directly to the World Board. A regional motion should only be used when all other avenues have been tried and exhausted. As described above, the conference is able to reach its best decisions only when adequate discussion of an idea has taken place. This takes place throughout a conference cycle.*

*There are a number of more effective ways to communicate your ideas: We have an Issue Discussion Board as well as a Conference Participant Bulletin Board; the World Board attends many forums and fellowship events; and the World Board members can be contacted individually or you can put your issue in front of the entire board. NAWS staff can also be contacted with questions at any time. Consensus-building takes communication and is only as effective as each participant makes it by their participation. It takes the ongoing involvement and participation of all conference participants in the two years between conferences to make this system successful. Ideas can build and grow and develop through ongoing discussion, and the board will help participants in any way they can.*

*From page 14: The Conference Agenda Report includes reports, proposals, and motions from the World Board and any proposals or motions submitted from regions. (Regional motions will be included in their own section and have the same number when presented on the conference floor.) Regional motions must be submitted two hundred and forty (240) days prior to the opening of the conference. All motions will include a written intent. Regions are allowed up to 150 words to describe the reasoning behind, and consequences of, their regional motions in the Conference Agenda Report. The World Board also includes a recommendation in order to provide the fellowship with as much information as possible when considering the idea*

We recently received copies of the NAWS Annual Report (2007-2008) and a review and input copy of the first 2 chapters of *"Living Clean"*, a book length piece currently in development. Links to this project and other topics from this report can be found at the end of this report.

Work continues on the Rural Recovery Workshop for WSNAC. We are presenting worksheets for approval to the Midwest Zonal Forum in Ohio next weekend. We have also presented a flier for approval to the WSNAC Committee. We look forward to seeing you all there at the workshop.

Last cycle we reported on our contact from the Iowa Region requesting help getting a facility on the Iowa side of our common border served with an H&I meeting. We are happy to report that there is now a monthly meeting going into that facility. We would like to extend our thanks to the "Prairie Dogs" in Prairie du Chien for stepping up. Your commitment and willingness serve as an example to us all.

Chris and I will be attending the Midwest Zonal Forum in Ohio on July 22-26. The Zonal Forum will meet on Friday evening starting at 6pm. On Saturday we will be in workshops with NAWS from 9am till 5pm. The workshops will be *"Our Freedom / Our Responsibility"*, *"Living Clean, the Journey Continues"*, and *"Our Service System"*. We look forward to bringing back lots of new information. The Zonal forum will meet again for a formal session on Sunday till about 3pm. The hotel room has been secured. We will be requesting funding for 4 days per diem at \$30 per day each (\$240) plus mileage of \$275. (1100 miles @ \$0.25 per mile)

### **NRIADA\_2009\_Report**

Greetings, For the 3rd consecutive year, the Wisconsin Regional Service Conference attended the National Rural Institute as it held its 25th Annual conference on Alcohol and Drug Abuse on May 31- June 4, 2009, in Menomonie, WI, at the University of Wisconsin Stout campus. Gene J. and Bill O. attended the exhibit for the Region. The conference provides participants the opportunity to personally interact with other rural alcohol and drug abuse professionals, federal agency representatives, and nationally known institute faculty and resource persons. This conference is unique in that it blends clinical and spiritual approaches to recovery in equal parts.

The Conference is co-Sponsored by:

- American Indians Against Abuse
- Center for Substance Abuse Prevention (CSAP)
- Center for Substance Abuse Treatment (CSAT)
- National Rural Alcohol & Drug Abuse Network, Inc. (NRADAN)
- Oneida Tribe of Indians of Wisconsin
- Scaife Family Foundation
- U.S. Department of Justice, Bureau of Justice Assistance
- Wisconsin Bureau on Mental Health and Substance Abuse

This year 39 states were represented, including Hawaii, with about 250 participants in all. We saw many of the same people again this year, made new friends, and were welcomed by all. Our exhibit was visited by most, if not all of the conference participants over the 3 ½ day run. Many of these visitors returned several times for additional literature and information. Several NA members were in attendance as conference participants, from as far away as Vermont and Hawaii, and NA meetings were available each night. Many took advantage of the opportunity.

Our participation in previous years has not gone unnoticed. In 2007, our first year of participation at this conference, many of the rural professionals did not know who we were. NA was virtually unknown. In many of these rural communities throughout the country, AA is the only program available. In 2008, our second year at the conference, the professionals in attendance now knew something about NA, and were beginning to recognize us. The seeds were planted.

This year, interest in our exhibit was much more pronounced. We displayed a full range of information pamphlets, White Books, CD's, mini's, and complete sets of books, in both English and Spanish. We also displayed key tags in all languages, and again, these drew much interest. The multi-language key tags started many conversations about the broad global scope of the NA program. The Spanish literature drew more attention than in previous years. The Wisconsin Regional Service Office (WRSO) brought books and some merchandise for display and sale. Our experience has been that the interested professionals wanted to purchase books, and we made them available for sale.

The conversations this year took on a different tone. Many of the professionals wanted more specific information than in previous years. The most common question we were asked this year was "What's the difference between NA and AA?". We were most happy to answer that in depth. Another was "How do we get a meeting started?". We were thanked many times for our presence, and asked if we would come back again next year. Our Public Relations efforts here are having a positive impact on the professionals in attendance and on recovery in rural communities across the country. Our public image as a viable program of recovery is growing in new places. The seeds are taking root and sprouting.

The opportunity exists for NA to get on the program as either a special topic (1 ½ hours) or a mini-workshop (4 ½ hours taught over 3 days). We could also provide an open speaker meeting one evening of the conference. We will be exploring these possibilities for future conferences. Our recommendation is to continue to support and attend this conference.
