Topics/ Discussion Board (3 Items)

November Fellowship Gathering

Discussion around the motion that region meet virtually with 2 yearly Fellowship Gatherings to ensure that we are meeting one another face to face. Questions of how long this would go on and clarified that this was the current policy going forward. What do individuals want to do for this Fellowship Gathering? Some discussion on that subject (speaker meeting, game night, etc.) Discussion on who would take the position of the Activities chair as this was an open position, RD volunteered, and was appointed to head this position. There will be an announcement for a planning for this event between now and the September Cycle. Information will be presented at the September regional meeting. Questioned if funds were needed between now and September, RD said not that she could think of. END OF TOPIC DISCUSSION

<u>Phoneline consolidation for WRSC</u>

Request for feedback from other areas as to how this was going. Questions about consolidation were addressed by the IT chair. 2 areas present stated they had no issues with a consolidated phoneline in the region. Discussion continued about sharing of volunteers and helping to keep the phoneline full. Stated this would help disperse the work for the phoneline individuals. Spoke of how this would help the region, IT chair spoke of the following: money savings (not as many phone numbers to maintain), consolidation of volunteers, pooling of resources, unity throughout our region. After a bit more discussion, next step decided is to gather a list of volunteers

throughout the region. There is currently a phoneline position in the IT subcommittee, will start with that individual. END OF TOPIC DISCUSSION.

WRSC shipping costs

Concern from an area regarding the high cost of shipping, especially that whether someone picked up the literature or had it delivered the shipping was still at 16%. Discussion about how to see what funds WRSO has available (does WRSC see the financials, will ask the WRSO Rep to ask). WRSO Rep was unavailable for the meeting but texted during the discussion that shipping should be addressed directly to the office. Decided there would be a group to put together a letter. The RCMA from MWASC volunteered to help pool folks to put this letter together. Decided there would be a meeting and someone would attempt to attend the WRSO meeting. Were told by the WRSO office manager that the next WRSO meeting was going to be help on July 25 in a hybrid fashion -no zoom ID available at this time. Hello family,

Thanks for allowing us to serve this body. We have been meeting on some Thursdays to ensure that we are able to keep communicating and keep the flow of information happening, there is a lot of information, and we are doing our best to keep it all straight and informed to this body.

There is also a workshop that has been created on how to be an RCM and these items may be of value to us, let us know if this body would like these items to help our RCMs.

Currently, along with the RD position for Wisconsin Region, I hold the position of Vice Treasurer for both the Midwest Regional Service-Learning Days (MRSLD), and the Multi Zonal Service Symposium (MZSS) planning teams. WRFD Chairperson report:

Thanks to all who have been participating in the Wisconsin Region Fellowship Development (WRFD) subcommittee meetings. Since the May cycle of the WRSC I haven't been asked to attend any other Area meetings. To date I've met with 5 Area's either the Area service or Group service meeting. Please let me know if your Area would like me to attend a service meeting virtually. This has been an ongoing task that I hope will develop into a stronger fellowship within the Wisconsin Region.

None of the budget approved by WRSC in May for the WRFD committee has been spent and I will let this body know if there is a need to do so.

Here are some important questions that were asked of myself and the committee. I'll do my best to address them now.

- 1. **Do I just meet with Areas in service meetings?** If you read the mission statement, Areas, Groups and Addicts. If an addict or Group would contact me I would help them to understand the service structure and offer help in anyway possible. I do not go out searching for Groups or addicts thereby going around the service structure for which they could find local answers or services.
- 2. What is the purpose of all the different subjects and possible solutions listed out? What is the WRFD committee doing with the listed possible solutions? The WRFD committee cannot have all the solutions for service and problems of the fellowship within the Wisconsin Region. The list is some of the main concerns and I believe the concerns from Addicts, Groups, and Areas throughout the Wisconsin Region. The best way to find solutions from the information listed is simply to read it and answer these questions at individual, Group and Area level. There isn't a better way then to get involved and seek out addicts willing to serve within the Group or Area and to provide them the resources necessary to find solutions. It starts with an individual addict with a desire to serve and continues to grow. Do my sponsee's serve or do service work within the fellowship? Do I announce upcoming service meetings no matter what meeting I attend? Do I explain what services are offered by the Group or Area? What is the 7th. Tradition spent on at the Group, Area and Region level?

The most encouraging idea put out by Dezzz G. the RD was to start up a newsletter which was something done in the past. So, we have begun to put together ides and the name of the news letter will be (ALL Voices Count). I'm not an editor and a writer by profession and I don't believe anyone should be concerned about this letter being anything more then your voice. We believe a good first topic could be in and coming out of the pandemic with respect to virtual, face to face and hybrid meetings. This could and should include any service committees, Area service meetings etc. Anyone can write their experience, strength and hope on the solutions, good, bad and difficult times to help others.
