My dog died due to poisoned dog food, my grandson was born on my father-in-law's birthday (February 23rd) my father-in-law then went into the hospital 2 days later and dies on March 2nd. We had the funeral for him on March 9th and I went on a plane on March 10th to look for a home for my family in Nevada. Came home on March 16th. On March 19th my mother-in-law fell after her church doings. On March 21st my mother-in-law was admitted in the hospital in a coma and non-responsive. April 2nd my mother-in-law was disconnected from life support. April 4th my mother-in-law died. April 5th I had 22 years clean and have yet to celebrate due to being in both a funeral home and a church to make arrangements for my mother-in- law. April 6th I headed to Detroit for the mid-west zonal forum. April 10th we had the funeral service for my mother-in-law. Since then I have been getting not one but two houses for sale. So I am continuously going back and forth between the houses. My husband's health has worsened since all of this and my health is in a decline due to having a stress related disease. I do not at this time have the finances or time and energy to just leave my husband who needs me so very much at this time. So this is my letter of resignation. I have thought long and hard on this and it is the right thing to do. Sometimes life on life's terms just plain sucks but I have an excellent support system here in Basic Area and in time will get through this. For having 22 years of clean time and being of service in one position or another for all but five months of my clean time, this is the first time I will not be fulfilling the term of this

I was contacted by the South East Family Area via Frank in regards to how to host Region and sent on to them the Regions guild lines on how to do this. Thanks for your understanding but I really need to step down. Please feel free to share this with whom ever else this affects.

I have not been to meetings, I have not been to church, and I have quit all of my study groups. I have pulled away from contact because talking with people makes me feel feelings, and I don't want to feel anything. At 13 years clean I am actually afraid of where I am, I don't like life, people, places or myself. Luckily I have people who are not giving up on me. I have a sponsor who is taking a bullwhip to my ass and offers of help me stay on target and not get overwhelmed. My paying job outside of NA is very demanding in March I was not able to take the day off of work as planned to finish the minutes. Which added to the depression because it had worked so well in January. Plus the stress that was happening at work that I felt I could not take a day off. At this point my job performance has also suffered. Luckily again for me they have provided a manpower temp to help carry some of the workload for a while. I am not sharing this for any reason but to let you know where I am. It is your responsibility, duty or whatever you want to call it to do what is best for this region. It was a struggle to come to a decision to not quit this position as I have quit just about everything else (and my sponsor has not suggested I quit at this point). But if you feel that what is best for this region is to replace me I do understand. At this point I cannot promise anything because I don't even believe my own promises. With that being said this weekend I am not capable of following the conversations for bullet points. Everything else in the minutes will remain the same hopefully by next cycle I will have some meetings and recovery back in my heart and will be able to multitask again. I don't have confidence in my ability this weekend to multitask anything. I do want to thank the people who emailed me, I know I did not respond – nothing personal to you I was just pulling away – but it did let me know I have been heard here.

Now for the same thing I say each region, I will send around a contact list please make any corrections / changes. I will do as I did last cycle (which worked well) I will make the changes tonight and tomorrow send it around again for you to verify the corrections.

I do not have the projector from my job this cycle it was broken.

I was told as I was setting up an area is missing their name card please make sure it is not stuck under yours. Also who's is missing I did not write it down. Please make sure they are returned to me at the end of region; please also let me know how many are missing. I did not bring my card stock paper this weekend so I can't print any this weekend.

SUBCOMMITTEE / ADHOC REPORTS:

Q. PUBLIC RELATIONS REPORT – 3:10pm PR REPORT

Dear Family, over the years, Public Relations has become a growing and evolving concern for all members of Narcotics Anonymous. It is the public's perception and image of our Fellowship that can determine whether an addict finds recovery. "The actions we take in forming relationships with the public can have a profound effect on whether or not addicts can find NA." (PR Handbook, p. 3)

The new Public Relations Handbook addresses this and many other facets of Public Relations. The old "Guide to Public Information" is no longer available. Area Public Relations subcommittees can easily obtain a copy of this handbook through the Service Office. Since its publication, NAWS has released additional resource information for 7 chapters. This is a total of 88 pages of additional resource information. There is extensive information on training for interacting with the public, as well as frequently asked questions and suggested answers. It is available from the NAWS website, http://www.na.org/PR/index.htm, or I can email it to you. We are pleased to announce the addition of a new webservant to our Web Group. Ren R. has an extensive background in the computer sciences, and has graciously stepped up to join our team. We welcome his experience and enthusiasm for the responsibilities that lie ahead. He is from the Badgerland Area, lives in Jefferson, and has 17 years clean. Ren is currently learning his new responsibilities and will be taking over the majority of the work on the site, as Valerie is going to be very busy having her baby in early June. We are still searching for one more person to serve as co-webservant.

Last cycle we were asked for some specific information concerning the NAWS Web Contact. I spoke with Steve R. and Mandy in Fellowship Services at NAWS. This is a complex issue that encompasses both technical and administrative responsibilities. I have a full report. (Put on board.)

The Regional directory is due to be published in July. This year, July is an unusual month. The first is a Sunday, and that means that the RSC is on the 14th & 15th, one week earlier than usual. The 4th of July is midweek. The printer needs at least 8 working days to print, fold, and deliver the directories. To meet the deadline, the file must go to the printer on July 2. I need 3 weeks to assemble the directory for printing. Therefore, the deadline for meeting list updates for the July edition will be June 10. We will, of course, try to accommodate late submissions, but the printer deadline is still July 2. We will supply all Areas with an excel file of what we currently have for your meeting list along with update instructions.

The NRIADA Conference is scheduled for June 3-7. We are requesting an advance of \$300 for expenses for the trip. The balance will be requested as reimbursement in July. We are also requesting \$50 for literature to add to the existing literature supplies.

Women & Poverty will be in September in Madison this year. The specific information has not yet been released. We will be requesting funding for this in July. (Put on board)

As discussed last cycle, NAWS has asked us to participate with them at the Wisconsin Correctional Assn. training conference to be held in September. This will be at the Kalahari Resort in the Dells. NAWS will provide the exhibit table, 2 badges, and may split the room cost with us. We would, once again, provide the bulk of the literature. No further information is available right now, but we would like to discuss this in

preparation for a funding motion at the July RSC. (Put on board.) The WAAODA Conference was this past week. A full report will be coming in July. That's all for now. Thank you for allowing me to serve.

NAWS REPORT

Hi, All, I spoke with Steve Rush in Fellowship services. As requested, here is the info on the NAWS Web contact. Each Region is allowed 2 web contacts that can have access to the NAWS database. As the RD is generally considered to be the first point of contact from NAWS to the Region, the RD is automatically granted access to the database as a web contact. All that needs to be done is to file the appropriate paperwork. It is not, however, considered to be in the scope of the RD's responsibility to make all the updates. NAWS experience is that the RD's have so much work already that it tends to be prohibitive of their time and energy to do all that and the web updates. That doesn't mean that they can't, either. That is left up to the individual Region or Area to decide. The Region can appoint, elect, or otherwise decide who is to be the other contact; that being the person who actually does the day-to day work of updating the database if the RD hasn't the resources.

There is much work to be done on the NAWS database within our Region. Many groups are not registered, and many more have not updated their information for many years. The initial task will take many hours of work. It will require the cooperation of all the Areas. Fellowship Services can assign a web contact liaison to assist us. Once the database is brought up to date, it will be much easier to maintain.

There are currently 3 Areas within our Region that have NAWS web contacts; Big Rivers, Woods & Waters, and Milwaukee. Milwaukee is just getting started. I will be working with our PR Chair here on this. I would like all your help in encouraging the Areas to take up this task in their own Areas. Some will be simple, and others will be very complicated.

There are no specific guidelines from NAWS as to who should be the designated web contact. That is left up to Regions and Areas to decide. As a new RD signs on as a contact, the former RD is removed. It is automatically granted to the RD as a logical outgrowth of the need for effective communication with the growing number of Regions and Areas. When NAWS wants to communicate with a Region, the RD is the first point of contact.

There are three documents involved in becoming a NAWS Web Contact. The first is a confidentiality agreement with NAWS. This is self- explanatory. The background document is general info. The instructions are much more complex. It has the step-by-step instructions for actually doing the updates. Mandy at NAWS ext. 180 will help get the contact person set up with a user name and password.

There is much more to this than just updating the NAWS website. We are also trying to update our own database to be consistent with the Regional, Area, and meeting codes currently in use on the NAWS database. This is what Larry was attempting to do. To this end, the NAWS contact person would also need to have access to the Regional website, and therefore, would also be a webservant with specific responsibilities.
