**REGIONAL DELEGATE:**

Dear Family,

The long wait for the highly anticipated Conference Agenda Report (CAR) is nearly over. The CAR will be released on November 27. I strongly urge all of you to obtain a copy. This will give you all as much time as possible to prepare for the CAR review in January. It will be posted online on the NAWS website. It will likely be a password protected document, but the password will also be there on the same page. As soon as I find it, I will send a note to the Secretary with the link and any additional instructions and info. We'll all soon know what surprises it contains.

The Conference Approval Track (CAT) will become available on January 27. It will contain all the NAWS strategic plans, budgets, and project plans with projected costs. There may also be an application from a Region or 2 or 3 for seating at the WSC. We can walk through that at the March RSC as we gather the conscience of the Region and your direction for the World Service Conference. This will also be posted on the NAWS website. As above, I urge you to download it and read it.

Since we already know that the CAR will include either motions or recommendations concerning the Service System Project (SSP), our round table today will focus on some history of the SSP, the current state of the SSP, and if time permits, a mock Group Support Forum.

Also to be included in the CAR will be an approval draft for the new IP "An Introduction to NA Meetings". There will also be a motion or a proposal on the direction the Traditions Book will take. These are just a few of the things on this cycle's agenda. Various Regions will have proposals to consider. There will be recommendations to terminate Delegate funding as well as ending Alternate Delegate attendance at the Conference.

It is likely that the WSC will approve the termination of automatic Delegate funding. It is far less likely that the ending of RDA attendance will pass. It would be wise of us to begin planning for that eventuality. It would double the cost of sending the Delegate Team to the WSC. If we start planning now, we will have 2 years to prepare.

Our Regional Report to NAWS is due by February 15, 2014 for inclusion in the Conference Report. This comes out in early April. This contains specifics and details pertaining to the daily activities at the Conference. It also contains the reports from all the Regions that make the deadline. The 2012 Conference report with all the Region reports was 448 pages. 50 of those pages were the actual conference schedule. The rest was Regional reports. There is a lot of information that will require input from all Areas as well as our Treasurer, PR and H&I Chairs. The report template is not yet available, so I have the 2012 form as a guide. Some of the information can be taken directly from the 2012 report, but much needs to be gathered here. (Put on board.)

The Midwest Zonal Forum is meeting this weekend at Greater Illinois' Regional Convention in Galesburg, IL. Not surprisingly, it is on our Regional weekend...again. The MZF is also planning a CAR/CAT review weekend on January 24-26 in Kalamazoo, MI. I questioned how they could accomplish that since the CAT isn't being released until the following Monday. I was informed that NAWS would be there and granted an early release of the CAT to this event. Since the CAR and CAT will contain very controversial proposals, motions, and recommendations, and at least one WB member will be there, (they usually send 2 WB and 1 or 2 staff) we believe it would be in our best interests to attend. It will also be very

informative, not to mention entertaining, to hear what the other Regions think and the questions they pose to the WB. We can then update you with any new information we get and discuss it before the WSC. The cutoff date for reservations is January 1, 2014. The hotel is \$75 per night plus \$8.25 tax for 2 nights for a total of \$166.50. Transportation from LaCrosse to Milwaukee, and then to Kalamazoo, MI is 444 miles each way. Travel costs would be 888 miles @ \$0.25 per mile or \$222. Per diem for 2 people for 3 days would be \$180. Grand total = \$568.50 (Put on board.)

### **REGIONAL DELEGATE ALTERNATE:**

Greetings everyone,

Due to some recent health issues, I will be unable to attend this cycle. For all those that have kept me in their thoughts and prayers, I thank you.

I have been monitoring the WSC participant discussion boards. Occasionally a good idea will be brought forward, but for the most part, discussions are based on personal opinion and occasional character bashing. With the exception of one or two occasions, I have not participated in conversations on the boards. Many participants have dropped off the boards for a variety of reasons which is irrelevant at this point. For the most part, the threads on the discussion boards have moved away from solutions to problems that are currently facing the worldwide fellowship of Narcotics Anonymous. The following are some of the discussions that have taken place so far:

There has been discussion about group conscience. I have watched participants on this thread all but destroy the purpose of what group conscience was designed to accomplish in Narcotics Anonymous. A few cycles ago we had a roundtable discussion about group conscience. I strongly suggest we review that round table discussion so that we can use true group conscience to strengthen and focus on our primary purpose as a region.

I have spent many hours reviewing a thread that questions why the World Board has in the past and currently needs an outside consultant to facilitate World Board meetings. World board members have tried to explain the necessity of having a consultant. It appears that there may be some dishonesty in those explanations. The root of this discussion appears to be in the compensation of this outside consultant. More will be revealed on this matter.

There's also a thread discussing the possibility of re-organizing the zones around the world so that zonal representation can be achieved and possibly reduce the number of participants at the World Service Conference. There has been discussion about reducing the Current 8 U.S. zones to approximately 3-6 zones. It appears that the only way that zonal representation will work, is if all zones become decision-making bodies and begin multitasking. This should prove to be an interesting discussion at the conference in April.

Probably the most important thread on the boards currently is about the Service System Project. It is important to recognize that this project is actually only a proposal at this time. The goal of the Service System Project was originally designed to investigate ways to improve services in Narcotics Anonymous and also reduce attendance and participation at the World Service Conference. Currently, one thing is clear; a motion or recommendation is going to be made by the World Board to approve the Group Service Forum (GSF), Local Service Conference (LSC), and Local Service Board portions of the proposed service system. I foresee problems with this motion or recommendation. I am sure that the presenters of the round table discussion this cycle involving the SSP will bring these possible problems to light. I cannot emphasize enough the importance of the RCM's of this region to fully inform their respective areas about

the proposed changes to our current service structure. One of the biggest sticking points is going to be if the groups, areas, and /or regions which choose not to participate in this new system, how will that affect regional representation at the world service conference in the future? The current response from World Board members is: “you will be out of the mainstream”. I am not sure what this statement implies. I hope everyone at this regional cycle participates and gains a better knowledge of what the future holds for the Wisconsin region in regards to the SSP.

The RD and myself will be presenting the C.A.R review at the January Regional Assembly. The amount of information that needs to be brought forth in January is massive. Because of this, the RD and myself agree that the regional body should suspend all nonessential reports so we may focus on the C.A.R. review. Reports that we feel are necessary in January will be approval of the minutes from the September cycle, the RD and RDA reports, and the Treasurer reports. I can only hope that the regional body agrees with this suggestion.

I hope that everyone has a prosperous and enjoyable holiday season. I fully intend to be at the January Regional Assembly. It is truly an honor to be of service to the Wisconsin region and its membership. In loving service, Harold L; Regional **Delegate Alternate**
