Hello Family; our thanks go out to the Upper Peninsula Area for hosting the Conference. Milwaukee Area continues to prosper. Most of our Area Service positions are filled. We still have vacancies at Vice-Chair and Vice-Secretary. We are beginning the process of an Area Inventory using the Area Planning Tool. Our goal is to improve services and to further carry the message of recovery to the addict who still suffers.

Milwaukee Area met last week and voted unanimously to reinstate the motion to increase the mileage reimbursement to Regional Trusted Servants from \$0.15 to \$0.25. We are reintroducing the motion today. Our

feelings are that the current mileage rate is insufficient and serves to discourage Trusted Servants as this puts an undue financial burden upon them. The 7th Tradition reminds us that "We cannot afford to let our members contribute more than their fair share." Our Area also discussed the idea of reducing the number of Regional Service meetings to 4 cycles per year. It is our belief that the RSC should continue its current meeting schedule of 6 cycles per year. We vigorously oppose any effort to change the schedule or centralize the RSC meetings, as this would deprive the Areas of the privilege and opportunity of hosting the RSC.

Plans are moving forward for the Greater Milwaukee Unity Convention. The date is Feb. 15-17 at the Radisson Hotel Milwaukee Airport. Please take fliers back to your Areas. We encourage you to register and make your hotel reservations early. Registration price increases after Dec 1, and the hotel room rate increases after January 15. We will have an outstanding program. Our annual free Thanksgiving Feast will be held on Thursday, November 22. We are still negotiating for a site, so there are no fliers at this time. R. **PUBLIC RELATIONS REPORT – TIME**

Dear Family, The Public Relations Web Group is pleased to announce the appointment of a new Regional NAWS Web Contact. He is Mike V., former Regional Webservant. Mike's service history, technical background, enthusiasm, and dedication to service make him an ideal candidate for this position. Mike is currently assessing the scope of the job and beginning the updates. He will be developing a process and protocols as the project develops. Our immediate goal is to assemble a comprehensive list of all unregistered meetings in the Region. We will then send the list to the Areas, asking for your cooperation in getting these meetings registered. As the responsibility for registering meetings rests first with the groups, we would ask that the Areas take up this task. Instructions and assistance will gladly be provided. Mike will also serve as a coordinator for Area NAWS Web Contacts. We envision the database update and registration process will take about a year to accomplish. After that, it will be maintenance. We encourage the Areas to actively participate in this process.

Our website domain (name registration) has been transferred to iPowerweb, the company that hosts the site. That gives us free domain for as long as we keep the hosting with them. That saves us \$35 per year. We would like to upgrade from our current 1 year hosting plan to a 3 year plan. This would net the Region an annual savings of about \$24. The total savings on both the domain and hosting would be \$59 per year. We are currently budgeted for only a 1 year plan at \$7.95 per month or \$95.40 per year. The new plan would be 3 years at \$5.95 per month for 36 months or \$214.20. We ask that you approve this upgrade in service. A motion to this effect has been presented. (Put on board) (Very time sensitive)

The 22nd annual Women & Poverty Conference was held in Madison on September 5-6. Vanessa V from Badgerland Area organized and coordinated our participation in the conference. Several members from the Area manned the exhibit. Interest in the exhibit was as expected, consistent with previous years. This year Colleen Rainey, the WISCAP project coordinator, waived the exhibit fee, citing our previous participation and the need and their desire for us to attend. We have returned the exhibit registration check to the Treasurer. We look forward to attending again next year and have extended our thanks to Ms. Rainey. (See attached report.)

The 3rd annual Mental Health and Substance Abuse Services Training Conference will be held on October 23-24 in Stevens Point. We have the exhibit application and are requesting \$350 in budgeted funding from the working reserve for the registration. The literature order has already been filled.

We were directed to obtain information and direction from NAWS concerning the State Prevention Conference. I contacted NAWS with the questions. Their position on this is simple. Narcotics Anonymous is focused on recovery from the disease of addiction, and not on prevention. They suggest that we not confuse our Primary Purpose and the public by attending such conferences. As stated, "It's not what we do."

Due to changes in the original plan, the funding for the Corrections Assn. conference will need to be altered. Gene is unable to attend, so I will be attending in his place. The literature has been ordered and delivered, and the hotel reservation is secured. The travel arrangements need to be discussed. The Conference begins on

Monday, so I will need to go to the Dells immediately following this RSC. This is very time sensitive and requires your immediate attention. (Put on board.)

I attended and participated in a multi-Regional PR Learning Day in Chicago on September 8. There were several workshops, and many local PR Chairs in attendance. I would like to suggest to the Activities Group the idea of a similar PR learning Day. As Public Relations grows and evolves, it becomes increasingly important to share our knowledge, information, and experience. Workshops on Public Image, PR and the Traditions, Helplines, Community Meetings, Health Care and Treatment facility presentations, poster and sign campaigns, Public Service Announcements, Power Point presentations, websites, conference exhibits, presentations to Corrections Departments, media, schools, frequently asked question and answers, PR resources, and more could be presented.

Women and Poverty Conference Report – September 5 and 6, 2007

Vanessa V. had organized and planned the Badgerland Area PI subcommittee's participation in the conference. The Badgerland Area PI subcommittee would like to formally thank Vanessa and her volunteers for making the conference a success. She reports that the Women & Poverty conference was successful, and proceeded without any problems. The Badgerland Area PI subcommittee provided local meeting lists, phonenumber flyers, a sample of all of the keytags, and books in English and in Spanish for demonstration copies only. The WI Region kindly paid the registration fee and provided the majority of the literature, which the amounts given and distributed are summarized below in the table. The Just for Today book, It Works book, and the 13 black and 15 white multiple language keytags were not used. The \$75 for literature in addition to the WRC PR subcommittee stock was sufficient for the conference.

After getting reports from all of the volunteers, the conference was reported as relatively small. There were not as many people coming by the exhibit tables, however, the professionals that did stayed longer, and were more intently focused on finding information and using NA as a resource for solving their clients' problems than at WAAODA. One professional asked about how to make clear the connection between drug use and violence to their clients. Another professional from the Dept. of Corrections in Janesville seemed interested in having IPs at their probation and parole offices. This professional was informed that the BASC PI subcommittee provides literature displays in each of the corrections (P&P) offices in Madison. Our subcommittee will look into adding Janesville to our list; however, it is difficult to reach rural areas in Wisconsin to keep such commitments fulfilled.

Hi family Tony an addict, Sorry I'm not able to attend this cycle, work schedule. I'm submitting this report in my absence. No one in any area has contacted me on the H&I efforts. So I'm pretty much a chair with no subcommittee and no input from others. Next cycle I would like so input from the RCM's on what my direction should be and duties you would like for me to carry out. May be helpful to get your area's H&I involved. I am currently involved in the ILUA H&I effort, and they have just elected a new chair. Looking forward to working with him. They have also gotten the H&I slot at WSNAC on ILUA's area H&I efforts. Writing steps to recovery: Got input from the ILUA and they think is a good idea for it to consist of a work group under H&I. I will have more to report on next cycle. I have one person who has contacted me in becoming involved, well actually three.

Things to think about: The subcommittee needs to meet monthly and which would probably not involve a rotating location of more then three areas, being Milwaukee, Oshkosh, and Madison.

A subcommittee members need to be gathered from the different areas.

Once subcommittee is formed, different facilities need to be approached to see if they would allow inmates to participate in this program, the step guides will probably need to be cleared through the DOC, but that's an unknown right now. A P.O box needs to be established, probably in the secretary's home town, or maybe the WRSO office if possible. Flyers need to be made, to announce the need for members, and all of this will require some funds. My email and phone number is listed in the minutes, any questions, please don't hesitate to ask.

RCMs, Please have thoughts inputs if possible for the next cycle. I don't forsee this program getting off the ground until late next year, to insure that we are as prepared as possible.

Could you have your H&I chairpersons contact me before next cycle if they would like their report included in the minutes. They should know that by including their report, that it may help another area that might be struggling with their H&I efforts, or may get some help if they or struggling with something in their H&I efforts. We share information in order to improve on our primary purpose,

“Carrying the message to the still suffering addict”.
