### General Summary:

- ?? The Hallo Communications (Phone Line) bill is currently being charged to an individual addict's charge card. The credit card billing was done when the original billing for the service was set up. Since the bill comes in every month the addict has to pay the bill each month and submit for reimbursements every 2 months. I contacted Hallo Communications and determined we can now setup the billing such that the bill will be paid directly from the checking account each month eliminating the need for an addict to pay the bill with their personal funds and wait to get their money back. It is my recommendation that we proceed with this change. A motion will follow.
- ?? I am still not a signer on the checking account. To minimize the number of changes to the account

signers, I was waiting for the new Alt Facilitator position to be filled this meeting so all the signer changes could be done at once.

?? The outstanding funds from the previous Functions Chair still has not been deposited or given to the treasurer. I have been told the money was given to another addict for deposit by previous Functions Chair and the other addict failed to make the deposit and has not been seen again. I was told the previous Functions Chair was going to make up the lost funds but it has not happened yet.

?? The last two donations to NAWS were sent in one envelope. The larger of the 2 checks (\$3,006.33) was never deposited. I contacted NAWS about the donation check not being cashed. I was told that they do not hold checks or original mailings. Therefore they must have missed the second check in the envelope and the \$3,006.33 was apparently destroyed. Therefore, I plan to void the original check in the account and send a replacement with this cycles donation.

Motion: Request approval to setup the Hallo Communications billing for the Phone Line to be directly debited from the checking account.

I am absent: NA meeting attendance has increased recently. The groups in our area are doing well and growing in the spirit of purpose and unity. The identity statement seems to be taking hold as there are less 'addict/andas'. The Chippewa Valley Area continues to consistently hold constructive and productive service committee and sub-committee meetings. GSR's and elected officials submit thorough and informative written reports, relevant to their positions. The minutes are compiled rapidly and electronically distributed. Hard copies are available at the following month's meeting. We have engaged in study, discussion, and application of the twelve traditions for our groups with an emphasis on "Robert's rules of order" for proper procedure in the conduct of area service. Area committee policies have also been revised. Concerns have been raised respecting adherence to the traditions. 4th tradition 'Autonomy' is compromised if a facility where a non-H&I meeting is held exerts governance over a group by restricting how the group is run and who can attend. 7th tradition issues have been addressed if a facility does not charge a fee for use of their property. We have also been concerned with accident liability and request information about what area activities are covered by the WRSC's blanket liability insurance policy. During the last cycle we have been in communication with Big Rivers regarding a service work 'learning day'

for our area. CVA requests that regional activities subcommittee sponsor and help to coordinate this function. Perhaps these workshops could be held in Eau Claire sometime this winter. Also we have reviewed the guidelines for hosting a regional conference and it would be a privilege to do so when CVA comes into rotation. We look forward to the opportunity.

The situation with our area website has been resolved; the site and the domain address will remain the same; CVANA.ORG. We have employed a special worker to provide web hosting services for a reasonable annual fee. With regard to the CVA help line 1-888-543-0924; we ask that the live addict option be removed from the menu and that the cell phone be disconnected.

As to the issue of social networking on face book and personal anonymity; GSR's have been advised to bring this conundrum to the groups for discussion and consensus so that we may form an area conscience on the matter; in order to assist the regional committee in resolution.
