Topic – NA Unity and the Clarity Message

Chippawa Vly started off topic Discussion:

Clarity of NA message and Unity very important and if very important for fellowship personal recount of a different fellowship trying to carry message. Very delicate topic with newcomers to how a person introduces self. We cannot do this alone.

How to carry the NA message in a clear message and unity in service

Area would like to tap into the knowledge of experienced members as they are a new area.

Clarification of how the round table is run, chairperson will facilitate

Thanking AA for guidance Service bulletin from 1985 – and our message was about addiction not the specific item or symptom specific – teaching newcomers about difference between AA & NA with respect to traditions of fellowships –

How to teach the message from that – solutions?

Service bodies need to follow and teach traditions not just steps – we individually need to lead from basic text

Using the clarity statement – not to dictate but to clarify – personal teaching outside of meeting – treatment centers teach about both

Clarity statement used at many groups and going to group homes to teach – treatment centers promote identification of both addict & alcoholic – maybe reach out to the homes and centers

PR & H&I to reach out to group homes and centers

Is a large problem – people feeling that they are being governed trying to teach and give message – we are actually all the same, apples & bananas all fruit – treatment centers to learn the difference area trying to teach – addicts being told what fellowship to attend – we need each other – promoting unity by making group inviting

Teaching by sponsorship

Another person about teaching by sponsorship – we need to teach where these ideals come from – we have never heard about to much unity – not new issue question has been around since have been a fellowship – each group comes up their boundaries – groups to decide clarity and tell us at region – bring topic up at each group meeting so people are opening books to look it up

In H&I each month this topic is brought up and what language is used at meetings to teach in the facilities – can also teach by sharing about this topic in while sharing – is important to also teach after meeting

time

One area using what they call “primary purpose teaching” a training that area does for people who are going into facilities to teach about carrying a clear NA message – treatment centers feel that there are meeting with people dealing and coming to meeting after using – treatment centers reaching out for temporary sponsors –

Being new in treatment did not know what we are and attending all fellowships – took time to learn that am a addict – dealing with new people do not feel comfortable telling a newcomer how to introduce self they don’t even know if they want to stay clean – will get understanding after time

This topic is showing a direction of how to introduce that is not the full clarity of the NA message – unity is not just about identification – how does introduction be the blurring of the message is this from – is this question from area, group or addicts what to do there is a difference – first time ever hearing clarity message felt uncomfortable, felt like membership requirement – are we picking and choosing parts of literature and what is actually dis-unity

This is brought up in an area quite often – can not forget how it is to be a newcomer – up to individual sharing – one of the stories in the basic text talks about being clean & sober, look up sober definition

Nothing better than sitting with someone when they understand the “and a” – leading by example by our own mistakes and saying to keep coming back – H&I meetings at facilities and using clean NA language – area would like to help the facilities understand language – literature does not mention identification – lets celebrate when someone is no longer a and a

There are 2 clarity statements, are you using the one out of pamphlet or using the one from introduction in basic text – clarity of NA message in one area is doing pretty good

Have done both fellowships for many years and is chemically dependant – the only requirement for membership is desire to stop using – do tell me who I am – telling me how to talk will move me out of the door – addict without home group is homeless addict – clarity is learned at different paces

Home group has many members from treatment centers – clarity statement made person uncomfortable – people quoting out of different books and being encouraged to read the book – takes time for message to relate to self – identification does not bother some people

SEPTEMBER REPORT

This cycle has once again been very interesting. Badgerland area has been struggling with financial issues having to do with reduced donations and adjusting budgets that were instituted at the beginning of the year to reflect the changes in income. This has been made more difficult by the fact that we have not had a single person treasurer from the start of the year, but have had several different people try to fulfill the duties of the position. Some of the people withdrew from all service at the area level as a result of not being able to do what needs to be done so there has been little continuity and things have been very disjointed. We still do not have an elected treasurer or vice treasurer at this time and the duties at this time are being handled by our vice-chair John H. We have had a number of activities (PR did the 2nd Janesville Critical Mass that returned about \$135.00 and our Primary Purpose campout that due to the weather lost money) and being true addicts there has been discord over where and how to trim the various subcommittee budgets to more accurately reflect available funds. I enjoyed the chance to do a workshop with Bill O. who came from Milwaukee to help out with the Janesville function where we blended service and the seventh tradition together for the workshop. We, in my opinion still need to address service as an enhancement to recovery to bolster the numbers of members that serve at all levels of the service structure. This would go a long way toward reducing the number of open service positions at the group and area levels. We are exploring the possibility of have a regional workshop on service such as we had 3 or 4 years ago done by Bill and Chris. While covering the Phone Line when our subcommittee chair was recuperating from a surgery I was made aware of the dearth of meetings between Madison and Dodgeville by the number of requests for information on meetings in that area. There are none at this time and I answered questions of just what is needed to start a meeting. Of course the first thing I stated is the need for someone to consistently be there to open the door and be there to run the meeting until others step forward to serve. I also let them know of the start up packets that Badgerland gives to new groups starting up and how to get them, show up at the area meeting and ask for them.

Administrative: There have been some changes in how we do business in the UPNA. At our last ASC meeting a vote was held to change our rotation of our monthly ASC meetings. The UPASC previously rotated the monthly ASC meeting amongst active groups in the area. Hospitals and Institutions: Our H & I subcommittee has held two jail and bails in conjunction with our unity picnics. They are in the process of getting literature into hospitals and institutions that we cannot get into physically. We currently have one operating H & I meeting in the Florence County Jail.

USFA Proposals: There has been much confusion regarding the proposals put out by the USFA, and also its purpose. I take blame for this and look to give a better explanation to groups in the UPNA so they can have a voice in this going forward. It is the conscience of the UPNA Area that we continue to gather information on this new proposal.

Report submitted by Activities vice chair

Our committee met in the other room with at first Chippewa Valley and Woods and Waters in attendance and then Big Rivers coming in mid meeting. We discussed with the chair of Chippewa valley activities many tips and helpful tidbit of info relating to event planning and production. She shared with us about the upcoming learning day October 22nd and the tentative dance around Valentines Day to be planned.

Woods and Waters thru previous communications have discussed with the committee the desire for Regional activities to do a joint event with them. We hammered out most of the details within the committee meeting and are as follows. With no objection we would like to do a campout during labor Day Weekend 2012 at little Girls Point in Iron Wood, Mi near the Wi., Mi. boarder. The event would be regionally sponsored and Woods and Waters Hosted. We would fund and receive the profit or loss and the area with our help would run the event. This would be a great opportunity to exercise unity in the fellowship. We would be renting the entire camp at a rate of 250 per night for 3 nights. We would be including 4 meals prepared by the hosting committee's food prep team, the registration, sat and sun breakfast and Dinner would be set at a tentative price of 35 per person 13 and above and if you desire a bed in the bunk style cabin an additional 10 dollar cost per bed. The cabin sleeps 35 and tent camping in the designated areas at the camp. Fri night we would have a pot luck dinner and meals or snacks between the provided, you would need to bring. The deposit would be 375 and we should have a contract from the camp and a flyer for distribution next Regional Service.

I have flyers here today for the ILUA / WRSC Unity Retreat we are sharing with ILUA on the weekend of Jan.20 2012. It is the weekend after Region in Jan!!! There is an optional Thursday night stay at \$15 and the registration in advance is \$70 and \$75 at the door. The event includes heated cabins with bunk style beds and 4 meals breakfast, lunch and dinner on sat and breakfast on Sun. with a potluck dinner Friday night and any other food or snacks you are welcome to bring. CVA

H&I is going well.

LE Phillips - The format that went by the contact at LE Phillips was not accepted. Mike D talked to her and she thought that the people go to enough meetings with readings etc. So we discussed just having the speaker at the beginning of sharing to let everyone know that he/she is there from Narcotics Anonymous. Mike is also working on getting more formats.

Arbor - we discussed leaving a format in a folder at Arbor so people don't have to keep bring it in. We also need more meeting lists for arbor...about 20.

Metro - Still working with the contact here. She is trying to get a meeting space set up and left message that

she would like to meet with me to discuss. I left 2 messages and am waiting to hear back from her.
Jackson correctional Facility - I need the applications back to send in.

Rock River

H&I at Winnebago County Men's Jail is back on track, but down to every other week. We are attempting to gain the support needed to be back in the jail every week. Need to talk to Thursday, Friday, and Saturday Rosecrance Detox about lack of support. Four of our PR and H&I members participated in the H&I Regional Round-Up. We have sent out a sign-up sheet to every group in our AREA in order to gain support for our H&I activities. The sign-up sheet has room to included phone number/clean date so that our subcommittee can find a place for any addict to observe/speak regardless of the various clean time requirements that are imposed by each facility. We have started making a point to have a PR and H&I booth at every AREA function to gain greater support and awareness for our subcommittee.
