The discussion of Zonal Representation and the possibility of a national service body have been in the forefront of discussions the last couple of weeks. As in the past, the discussions initially involve personality differences. Eventually people shift back to the topic at hand.

Last cycle we had a USSC presentation. The main purpose for the presentation was to straighten out misconceptions and misinformation about the USSC to the membership of RRAGS. It was mentioned that the RRAGG was about to discontinue donations to the USSC. There are individuals in the RRAGS spearheading this movement. The USSC presentation was given for their benefit, however, those individuals were not in attendance at the presentation. It is truly unfortunate that individuals such as these would rather continue in the drama rather than have more accurate information in which to make decisions. I hope that these individuals and the lack of their attendance at the presentation are made known to their local fellowship.

Last cycle we began discussions regarding WRSC participation at the Midwest Zonal Forum (MZF). The bottom line is creating a vehicle (Zone) in which to shift from “individual regional representation” at the World Service Conference (WSC), to what in the future may be called “zonal representation”.

The Multi-zonal Service Symposium (MZSS) will be having numerous workshops and discussions about the future of NA in the United States. The Wisconsin Region has traditionally been at the forefront of discussions involving NA in the United States and around the world. The RD and I believe we should re-think our involvement and participation in the MZF. We feel it would be of great benefit to send one of the RD team to the MZSS. The RD and I are submitting financial proposals. (See attachment for proposed expenses) I hope this topic will be thoroughly discussed during this cycle. If the body wishes, a check for the proposed amount can be mailed to me, or I can submit all receipts at the November cycle for reimbursement. It is an honor to serve as a member of the WRSC RD team.

Greetings from the Milwaukee/Waukesha Area. As has been reported our Area has been undertaking a major transition to a new vision of NA service in our area that includes local service boards/committees (LSB/LSC) and group support forums (GSF). Since our last regional meeting we held our first GSF and I am happy to report that it went well. We elected a GSF moderator who is not associated with facilitating local business meetings. Tomorrow will be our second GSF meeting and along with providing a forum for members and GSR's to discuss issues related to group level NA, we will also be holding a workshop on building strong home groups.
